- This will be a contract with locked UNIT PRICES having validity of 12 months with **Closed** CAP Value of **PKR 150 million** annually.
- Unit Price will be locked for 1 years till the validity of the contract.
- Upon expiration of the contract, this Agreement shall deemed to have been renewed automatically for next three months by the consent of both parties
- KE will issue Release Order (RO) based on the quantity required which will be supplied by the vendor within mentioned delivery time.
- Vendor to confirm stock availability. In case of availability, order to be placed within 7 days with delivery time of 30 days. If stock is unavailable, delivery time will be 60 days.
- KE has the right to split this contract in more than one suppliers/vendors.
- Payment terms will be "60 days after the submission of invoices/delivery challan" for this Contract.
- KE standards terms and conditions shall be applicable unless otherwise specified in all released orders.
- KE reserves the right to reject any bid and withdraw the bidding process at any time either without incurring any liability on the affected bidder(s) or any obligation to inform the involved bidder(s).
