*This is in continuation of the disclosure made by K-Electric Limited ("the Company") on November 5, 2025 relating to filing of Constitutional Petitions Nos. D-5384 of 2025, D-5385 of 2025, D-5386 of 2025 and D-5387 of 2025 before the Honorable Sindh High Court, Karachi, ("the Honorable Court") and passing of the interim orders by the Honorable Court to the effect that no coercive action shall be taken against the petitioner in terms of NEPRA's review decisions dated October 20, 2025 ("the impugned decisions").*

*It is further informed that the Honorable Court vide Order dated April 2, 2026, has disposed the above petitions filed by KE with the direction to the NEPRA Appellate Tribunal (which has recently become functional), before which the Company had filed appeals under section 12-G of NEPRA Act, 1997 against the impugned decisions, to decide KE's pending appeals within a period of three (03) months.*

*The Honorable Court has further directed that the interim order earlier passed by it shall remain in force and continue until the final decision is reached by the Tribunal in the pending appeals.*
